#### A BILL

To apply for a further sum of nine hundred and sixty-nine million two hundred and thirteen thousand and one hundred and two rupees (Rs. 969,213,102) to the service of the Government for financial year 2006-2007

**ENACTED** by the Parliament of Mauritius, as follows -

#### 1. Short title

This Act may be cited as the Supplementary Appropriation (2006-2007) Act 2007.

### 2. Appropriation of excess expenditure for 2006-2007

The sum of nine hundred and sixty-nine million two hundred and thirteen thousand and one hundred and two rupees (Rs. 969,213,102) consisting of the amounts specified in the Schedule, which was duly paid and applied to the services of the Government during the financial year 2006-2007, is declared to have been validly paid out of the Consolidated Fund.
