#### A BILL

To provide for the replenishment of the Contingencies Fund for sums advanced for payment for, and application to, urgent and unforeseen expenditure of the Government during the present financial year 2005-2006

ENACTED by the Parliament of Mauritius, as follows -

#### 1. Short title

This Act may be cited as the Replenishment of the Contingencies Fund (2005-2006) Act 2006.

# 2. Replenishment of advance during financial year 2005-2006 from Contingencies Fund

The Contingencies Fund is replenished by a transfer from the Consolidated Fund of the sum of one billion five hundred and eighty-two million three hundred and thirty thousand and one hundred and ten rupees, being equivalent to the advance made from the Contingencies Fund, and consisting of the amounts specified in the Schedule, which was so advanced for payment for, and application to, urgent and unforeseen expenditure of the Government during the present financial year 2005-2006.
