## A BILL

### To amend the Road Traffic Act

ENACTED by the Parliament of Mauritius, as follows –

**1. Short title**

This Act may be cited as the Road Traffic (Amendment No. 2) Act 2019.

**2. Interpretation**

In this Act –

“principal Act” means the Road Traffic Act.

### 3. Section 2 of principal Act amended

Section 2 of the principal Act is amended –

- (a) in the definition of “authorised examiner”, by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (b) in the definition of “authorised officer”, by deleting the word “Commissioner” wherever it appears and replacing it by the words “Chief Commissioner”;
- (c) by deleting the definition of “Authority”;
- (d) by deleting the definition of “Commissioner”;
- (e) in the definition of “conductor”, in paragraph (a), by deleting the words “the Authority” and replacing them by the word “NLTA”;
- (f) in the definition of “current registration mark”, by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (g) by deleting the definition of “electric motor vehicle” and replacing it by the following definition –
  - “electric motor vehicle” –
  - (a) means a vehicle which is powered by an electric motor drawing current from –
    - (i) rechargeable storage batteries, fuel cells, or other portable sources of electrical current; or
    - (ii) a non-electrical source of power designed to charge batteries and their components; but
  - (b) does not include a light rail vehicle;
- (h) by deleting the definition of “motor vehicle” and replacing it by the following definition –

“motor vehicle” –

- (a) means a vehicle which is self-propelled by means of motor, intended for use, or capable of being used, on roads unless the vehicle has, by regulations, been excluded from this definition; and
- (b) includes –
  - (i) a vehicle propelled by a combustion engine;
  - (ii) an electric motor vehicle; and
  - (iii) a hybrid motor vehicle;
- (i) in the definition of “personalised registration mark”, in paragraph (b), by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (j) in the definition of “registration mark”, by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (k) in the definition of “road”, by adding the following new paragraph, the word “and” being added at the end of paragraph (d) and the word “and” at the end of paragraph (c) being deleted –
  - (e) a level crossing;
- (l) in the definition of “road transport inspector”, by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (m) in the definition of “stand regulator”, by deleting the words “the Authority” and replacing them by the word “NLTA”;
- (n) in the definition of “total piston displacement”, in paragraphs (b) and (c), by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (o) in the definition of “traffic warden”, by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;
- (p) in the definition of “trailer”, in paragraph (a), by inserting, after the words “a vehicle”, the words “, other than a light rail vehicle,”;

(q) in the definition of “vehicle examiner”, by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”;

(r) by inserting, in the appropriate alphabetical order, the following new definitions –

“Appeal Committee” means the Appeal Committee set up under the National Land Transport Authority 2019;

“Chief Commissioner” means the Chief National Transport Commissioner referred to in the National Land Transport Authority Act 2019;

“level crossing” has the same meaning as in the Light Rail Act 2019;

“light rail vehicle” has the same meaning as in the Light Rail Act 2019;

“NLTA” means the National Land Transport Authority referred to in the National Land Transport Authority Act 2019;

#### **4. Section 3 of principal Act amended**

Section 3 of the principal Act is amended –

(a) by repealing subsection (1) and replacing it by the following subsection –

(1) The Chief Commissioner shall exercise such powers as are conferred, and perform such duties as are imposed, on him by this Act or any other enactment.

  - (i) in paragraph (b), by deleting the words “The Authority” and replacing them by the word “NLTA”;

- (ii) in paragraph (c), by deleting the words “the Authority” wherever they appear and replacing them by the word “NLTA”;
- (f) in subsection (8), by deleting the words “the Authority”, “Minister” and “Permanent Secretary” and replacing them by the words “NLTA”, “Appeal Committee” and “Secretary to the Appeal Committee”, respectively;
- (g) in subsection (9)(b), by deleting the words “the Authority” and replacing them by the word “NLTA”.

**71. Section 169 of principal Act amended**

Section 169 of the principal Act is amended by deleting the word “Minister” wherever it appears and replacing it by the words “Appeal Committee”.

**72. Section 173 of principal Act amended**

Section 173 of the principal Act is amended, in subsection (3)(b)(i), by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”.

**73. Section 173A of principal Act amended**

Section 173A of the principal Act is amended –

- (a) in subsection (1), by deleting the words “on behalf of the Commissioner” and replacing them by the words “on behalf of the Chief Commissioner”;
- (b) in subsection (2) –
  - (i) in paragraph (a), by deleting the words “section 173, the Commissioner” and replacing them by the words “section 173, the Chief Commissioner”;
  - (ii) in paragraph (b), by deleting the words “its detention, the Commissioner” and replacing them by the words “its detention, the Chief Commissioner”.

**74. Section 177 of principal Act amended**

Section 177 of the principal Act is amended –

- (a) in the heading, by deleting the word “**Commissioner**” and replacing it by the words “**Chief Commissioner**”;
- (b) by deleting the word “Commissioner” wherever it appears and replacing it by the words “Chief Commissioner”.

**75. Section 178A of principal Act amended**

Section 178A of the principal Act is amended, in subsection (3) –

- (a) in paragraph (c), by deleting the words “Traffic Management Unit” and replacing them by the words “Traffic Management and Road Safety Unit”;
- (b) in paragraph (f), by deleting the words “the National Transport Authority” and replacing them by the word “NLTA”.

**76. Section 178B of principal Act amended**

Section 178B of the principal Act is amended, in subsection (3)(b), by deleting the words “the National Transport Authority” and replacing them by the words “NLTA”.

**77. Section 184 of principal Act amended**

Section 184 of the principal Act is amended, in subsection (4)(b)(ii), by deleting the words “light railway” and replacing them by the words “light rail”.

**78. Section 188 of principal Act amended**

Section 188 of the principal Act is amended, in subsection (2)(b), by deleting the word “Commissioner” and replacing it by the words “Chief Commissioner”.

**79. Commencement**

(1) Subject to subsection (2), this Act shall come into operation on a date to be fixed by Proclamation.

(2) Different dates may be fixed for the coming into operation of different sections of this Act.
