Proclamation opening the First Session of the Eighth National Assembly.

Hon. Ministers and hon. Members, today's Sitting is being held following the issue of Proclamation No. 50 of 2024, under the hand and seal of His Excellency, Mr Prithvirajsing Roopun, Grand Commander of the Order of the Star and Key of the Indian Ocean, President of the Republic of Mauritius. I shall, in compliance with Standing Order 3 of the Standing Orders and Rules of the National Assembly 1995, read out the Proclamation.

**Proclamation No. 50 of 2024**

**TO PROCLAIM THE OPENING OF THE  
FIRST SESSION OF THE EIGHTH NATIONAL ASSEMBLY**

**PRITHVIRAJ SING ROOPUN**

*President of the Republic of Mauritius*

PRITHVIRAJ SING ROOPUN – *By His Excellency Mr PRITHVIRAJ SING ROOPUN, Grand Commander of the Order of the Star and Key of the Indian Ocean, President of the Republic of Mauritius*

*&c. &c. &c.*

**WHEREAS** by section 56(1) of the Constitution of Mauritius, it is provided that the sessions of the National Assembly shall be held in such place and begin at such time as the President by Proclamation may appoint;

**AND WHEREAS** it is further enacted by section 56(4) of the Constitution that a session of the National Assembly shall be appointed to commence within thirty days of the date prescribed for polling at any general election;

**NOW, THEREFORE,** in the exercise of the powers vested in me as aforesaid, I do

hereby proclaim that the First Session of the Eighth National Assembly shall begin on the 29<sup>th</sup> day of November two thousand and twenty-four, and that the first Sitting of the Eighth National Assembly in its First Session shall be held on the day aforesaid at 15 00 hours in the Chamber of the Assembly in Port Louis.

Given at State House, Le Réduit, this 27<sup>th</sup> day of November two thousand and twenty-four.

**Administration of Oath of Allegiance to or Affirmation or Declaration by Members.**

Hon. Members, Standing Order 4(1) of the Standing Orders and Rules of the National Assembly requires that Oath of Allegiance to or Affirmation or Declaration shall be subscribed or made, as the case may be, prior to any Member taking part in the proceedings of the Assembly, other than the proceedings necessary for the purpose of this Order.

I shall, therefore, proceed in the following order: Dr. the Hon. Prime Minister, Leader of the House, will be called first, followed by the hon. Deputy Prime Minister and hon. Ministers in turn in order of precedence to come to the upper step, first to make and subscribe the Oath of Allegiance to or Affirmation or Declaration prescribed in Schedule 3 of the Constitution and sign the Roll of Membership at the Table prior to taking their respective seats.

Thereafter, the hon. Leader of the Opposition, hon. Junior Ministers, in order of precedence, followed by hon. Members in alphabetical order, shall be invited to come forward to make and subscribe the Oath of Allegiance prescribed in Schedule 3 of the Constitution and sign the Roll of Membership and to take their respective seats.

As such, we will start.

### **SPEAKER – ELECTION**

**The Ag. Clerk:** Hon. Members, in accordance with the provisions of Section 32 of the Constitution and of Standing Order 7 of the Standing Orders and Rules of the National Assembly, the Assembly will now proceed with the election of a Speaker.

I will, therefore, invite two hon. Members to move and to second the election of a Member present in this Assembly or otherwise, to be nominated to the office of Speaker and to take the Chair of the Assembly as such.

**The Prime Minister:** Acting Clerk, in accordance with the provisions of Section 32 of the Constitution and Standing Order 7 of the Standing Orders and Rules of the National Assembly, I move that Mrs Shirin Aumeeruddy-Cziffra be elected Speaker of the House.

Acting Clerk, Mrs Shirin Aumeeruddy-Cziffra is a Barrister-at-Law and was called to the Bar in Mauritius in July 1974, and practiced law for about 26 years.

During her professional career, she occupied several positions of responsibility. She was elected in Constituency No. 19, Stanley and Rose Hill in 1976 and then in 1982, 1983, and 1987.

In 1982, she was appointed Attorney-General and Minister for Women's Rights and Family Welfare.

In 1987, she was elected Municipal Councillor and appointed Mayor of Beau Bassin-Rose Hill.

From 1992 to 1994, she was the Ambassador of Mauritius to the Republic of France, Italy, Spain, and Portugal.

In 2004, Mrs Aumeeruddy-Cziffra was appointed Ombudsperson for Children and remained in that position up to 2011.

From 2012 to 2021, she was Chairperson of the Public Bodies Appeal Tribunal following which, she resumed the profession of Barrister-at-Law.

Mrs Aumeeruddy-Cziffra is known at the national, regional, and international levels as being deeply committed to the promotion of human rights.

It is with pleasure that I move that Mrs Aumeeruddy-Cziffra be elected Speaker of this august Assembly.

**The Leader of the Opposition (Mr G. Mrs Shirin Aumeeruddy-Cziffra then made and subscribed before the Assembly the Oath of Allegiance prescribed in the Third Schedule of the Constitution and signed the Roll of Membership.

**Madam Speaker** (*Standing on the upper step*):

Rt. Hon. Prime Minister and Leader of the House, thank you. Hon. Deputy Prime Minister, hon. Leader of the Opposition, hon. Ministers, hon. Junior Ministers, hon. Members, thank you for your trust and confidence.

First of all, let me congratulate each and every one of you for your personal success which has brought you to sit in the National Assembly in your various capacities.

The future of our country is now in your hands, in whatever position you may occupy. I feel deeply honoured to become Speaker at such a challenging time.

I know that you will express yourselves with conviction and passion, and I will naturally promote the fundamental rights and freedoms guaranteed by Chapter II of our Constitution, in particular the liberty of opinion and expression.

I will do my best to abide by the Standing Orders and Rules of the National Assembly which, of course, will need to be reviewed so that we enlarge the rights of one and all.

I would like to thank the Acting Clerk and the whole staff who have done their best to ensure that this First Session of the Eighth National Assembly takes place as smoothly as possible. I count on them to continue to uphold the high standards of our august Assembly.

My motto is contained in three Rs: Rights, Respect, Responsibility. Let us together restore the dignity of this House. By so doing, let us also inspire the people who are watching us and thus promote a scrupulous democracy, not just in the National Assembly but throughout the Republic of Mauritius.

**CHAGOS ARCHIPELAGO – SOVEREIGNTY – DRAFT AGREEMENT**

**The Prime Minister:** Madam Speaker, as the House is aware, on 03 October 2024, on the eve of the dissolution of Parliament, Mauritius and the United Kingdom issued a joint statement confirming that after 13 rounds of negotiations, the Prime Ministers of the two countries had reached a political agreement on the exercise on the sovereignty over the Chagos Archipelago.

Since the progress made in and the contents of the negotiations between Mauritius and the United Kingdom during the past two years were unknown to the new Government, I have had discussions with local officials and external legal advisers since my assumption of office regarding the status of the negotiations.

The British Prime Minister, the Rt. Hon. Sir Keir Starmer, sent his political envoy, Mr Jonathan Powell to meet with me on 25 November last and he has briefed me on what has been proposed in the draft agreement.

I wish to inform the House that I have asked for an independent review of the confidential draft agreement agreed so far.

I will keep the House informed of the next steps in the negotiations after Cabinet will have had the opportunity to consider the outcome of the review exercise and any related discussions thereupon with the local and external officials and advisers.

**MARE CHICOSE LANDFILL - FIRE OUTBREAK - 05 NOVEMBER 2024**

**The Minister of Environment, Solid Waste Management and Climate Change (Mr R. Bhagwan):** Thank you, Madam Speaker. With your permission, I would like to make a statement on the fire outbreak at Mare Chicose Landfill which occurred on the night of 05 November 2024.

Following my swearing in as Minister of Environment, Solid Waste Management and Climate Change, I carried out a visit at the site on Saturday 23 November 2024 together with Junior Ministers and other MPs of the constituency to take cognizance of the situation and to look into ways and means of scaling up the rate of extinguishing fire.

I was informed that immediately after the fire outbreak, fire fighters from the Mauritius Fire Rescue Service were deployed on the site to combat the fire, and are still there. The fire spread over an extent of around 42,300 m<sup>2</sup>, owing to the dry nature of the waste and the prevailing windy weather. Every effort is being made to contain the fire. The advice of the experts from the Reunion Fire Authorities was sought, and they were agreeable on the methodology adopted by the Mauritius Fire Rescue Service, that is, breaking of the waste mass by means of excavators, cooling by application of water, and finally, covering the extinguished waste with soil.

A Coordination Committee chaired by the Solid Waste Management Division of my Ministry with representatives of the main stakeholders such as the Mauritius Fire Rescue Service, Police, Special Mobile Force, the National Environmental Laboratory, the local authorities, the Ministry of Health and Wellness, as well as the contractor and consultant meet on a daily basis to coordinate the actions, interventions required to combat the fire.

We have sought the collaboration of the private sector, NGOs and the community at large. The fire has been subdued to around 50% as at today. With the current rate of progress, it is expected that the fire will be completely extinguished by mid-December 2024.

The National Environmental Laboratory of my Ministry is and will continue monitoring the air quality of the surrounding regions of the landfill on a daily basis. Test results show no toxic gases.

Moreover, the Ministry of Health and Wellness has provided ambulances and extended its services to assist and intervene in any case of sickness or minor casualty on site and neighbouring localities.

I wish to place on record my appreciation for the valuable support of the fire fighters, the private sector, NGOs, various public authorities, the different Units of my Ministry, the Police, the *Police de l'environnement*, the Special Mobile Force, health authorities, the civil society, as well as my colleague, the Minister of Local Government, and the MPs of the constituency.

Madam Speaker, I shall come up with a more comprehensive statement on the issue and the whole solid waste management system. Thank you.
